Hello All-

I wanted to take the time to announce some very important and **EXCITING** changes coming to our Faculty and Employee Assistance Program (FEAP). As many of you probably already know we have partnered with UNMC to provide FEAP services to our faculty and staff for the past 27 years. For the last 7-8 months, I along with the HR Director (Aileen Warren), at UNMC have analyzed the current FEAP services being offered, taking into consideration what is working well and what needs improving, as well as, the pros and cons of having an in-house versus external vendor provide the needed services. With the recent retirement of Marlene Schneider (FEAP Coordinator that supported UNO) it has become imperative that we find a solution that meets the needs of our faculty and staff.

The decision was made that the needs of both our Faculty and Staff are best met by utilizing an external FEAP provider. We have decided to contract with BEST CARE EAP, who has a strong track record of service and currently has a contract with the University of Nebraska-Kearney.
