In accordance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1990, 20 U.S.C. Sec 1092, the University of Nebraska at Omaha provides information relating to crime statistics and policies concerning campus security to current students, faculty and staff. The law requires colleges and universities to publish and distribute, through publications, mailings or Internet or Intranet websites, an annual report. The report must be distributed in October each year.

This is to notify all UNO students, faculty and staff that the most current Annual Report is now available online. The information can be viewed by going to the Campus Security website and select Campus Security and Fire Safety Report on the left hand side.

In addition, Campus Security posts security safety alerts and other security and personal safety-related information on this site. Employees and students are encouraged to review the information on a routine basis and contact Campus Security with any questions or concerns.

Faculty, staff, and students are also encouraged to review personal safety videos and safety services below.

EMERGENCY NOTIFICATION SERVICE

e2 Campus is an emergency notification service that is used by UNO to notify students, faculty and staff in the event of life threatening or critical events on campus. It sends text messages to cell phones or e-mail to those who register.

U-TIP FOR ANONYMOUS TEXT MESSAGE

Use U-Tip to report suspicious activities or individuals on campus, such as theft or vandalism. Communication is anonymous. The message will be sent directly to Campus Security and appropriate action will be taken immediately. All other emergency calls should be made to Campus Security at 402.554.2911 or Omaha Police and Fire at 911, so more information can be gathered from the caller. To use the system simply enter 50911 in the address box. In the text message type UNO911 (your message here).
