

PURPOSE OF THE SURVEY

The Center for Statistics (CS) will collect enrollment data through this component of IPEDS each year in order to update several annual publications including its college enrollment projections, the Digest of Education Statistics and the Condition of Education. Racial/ethnic data are necessary for the Office for Civil Rights to perform functions mandated by Title VI and Title IX and to aid in the monitoring of desegregation plans. IPEDS fall enrollment by age of student will offer insight into the relationship between the changing demographics of college-going cohorts and enrollment in different types of postsecondary institutions.

USES OF DATA

Fall enrollment traditionally is used to measure student access to postsecondary education and IPEDS will continue to provide this important statistical series. The Department also uses fall enrollment data in program planning and for setting funding allocation standards for legislatively controlled programs. Other Federal and State agencies use enrollment data in policymaking decisions, economic and financial planning, manpower forecasting, and policy formulation.

Designations are requested only for United States citizens and for resident aliens, persons who have been lawfully admitted for permanent residence (and who hold alien registration receipt cards - Form I-551/155).

Report non-resident aliens in columns 1 and 2 only, regardless of their race/ethnicity. Assign other students to one of the columns 3 through 12 based on information available to the institution.

- A. Subtotals. Part A is organized to provide several edit checks of specific cell counts against totals. Totals of Full-Time Undergraduate Students (line 08) and Full-Time Postbaccalaureate Students (line 14), when added to the Part-Time undergraduates (line 22) and the Part-Time Postbaccalaureates (line 28), should sum to the GRAND TOTAL, ALL STUDENTS (line 29) for each of the columns.
- B. Cross-Section Checks. The total for full-time students, Part B, Line 12, Columns 09 and 10 should equal the total for full-time students, Part A, Lines 8 + 14, Columns 13 and 14. Similarly, the total for part-time students, Part B, Line 24, Columns 09 and 10 should equal Part A, Lines 22 + 28, Columns 13 and 14. ASIAN OR PACIFIC ISLANDER. A person having origins in any of the original peoples of the Far East, Southeast Asia, the Indian Subcontinent, or Pacific Islands. This includes people from China, Japan, Korea, the Philippine Islands, Samoa, India and Vietnam.

BLACK, NON-HISPANIC. A person having origins in any of the black racial groups of Africa (except those of Hispanic origin).

CREDIT. Recognition of attendance and/or performance in an instructional activity (course or program) that can be applied by a recipient to requirements for a degree, diploma, certificate or other formal award.

CREDIT COURSE. A course that, if successfully completed, can be applied toward the number of courses required for achieving a degree, diploma, certificate, or other formal award.

DEGREE SEEKING STUDENTS. Students enrolled in courses for credit who are recognized by the institution as earning credit toward a degree or formal award. At the undergraduate level, this is intended to include students enrolled in vocational or occupational programs.

FIRST-PROFESSIONAL STUDENT. A student enrolled in any of the following degree programs:

FIRST-TIME FIRST-PROFESSIONAL STUDENT. A student enrolled for the first time in a first-professional degree program. Includes first-professional students enrolled in the fall term who entered the institution in the prior summer term.

FIRST-TIME FRESHMAN. An entering freshman who has never attended any college. Includes students enrolled in the fall term who attended college for the first time in the prior summer term. Also includes students who entered with advanced standing (college credits earned before graduation from high school).

FIRST-TIME GRADUATE-LEVEL STUDENT. A person enrolled at the graduate level for the first time. Includes graduate students enrolled in the fall term who attended graduate school in the prior summer term.

FIRST-TIME STUDENT. A student attending any institution for the first time. That is, the student enters an institution with no credit toward a degree or award at the level enrolled. (e.g., graduate student or first-professional student).

FIRST-YEAR STUDENT. A student who has completed less than the equivalent of one full year of undergraduate work, that is, less than 30 semester hours in a 120 hour degree program.

FOURTH YEAR AND BEYOND. An undergraduate student who has completed the equivalent of three years of full-time undergraduate work, that is, at least 90 semester hours in a 120 hour degree program.

FRESHMAN. A first year undergraduate student.

FULL-TIME STUDENT.

Undergraduate: A student enrolled for 12 or more semester credits; or 12 or more quarter credits; or 24 contact hours a week each term.

Graduate: A student enrolled for 9 or more semester credits, or 9 or more quarter credits.

First-Professional: As defined by the institution.

GRADUATE STUDENT. A student who holds a bachelor's or first-professional degree, or equivalent, and is taking courses at the postbaccalaureate level. These students may or may not be enrolled in graduate programs.

HISPANIC. A person of Mexican, Puerto Rican, Cuban, Central or South American or other Spanish culture or origin, regardless of race.

NON-CREDIT COURSE. A course or activity having no credit applicable toward a degree, diploma, certificate, or other formal award.

NON-DEGREE SEEKING STUDENTS. Students enrolled in courses for credit who are not recognized by the institution as earning credit for a degree or formal award.

NON-RESIDENT ALIEN. A person who is not a citizen or national of the United States and who is in this country on a visa or temporary basis and does not have the right to remain indefinitely.

OFF-CAMPUS CENTERS (EXTENSION CENTERS). A site of an educational institution that is outside the physical confines of its parent institution, that is not temporary, and offers courses that are part of an organized program at the parent institution.

OFFICIAL FALL REPORTING DATE. The date (in the fall) on which an institution must report fall enrollment data to either the State, its board of trustees, or some other external governing body.

PART-TIME STUDENT.

Undergraduate: A student enrolled for 11 semester credits or less, or 11 quarter credits or less, or less than 24 contact hours per week.

Graduate: A student enrolled for 8 semester credits or less, or 8 quarter credits or less.

POSTBACCALAUREATE STUDENT. A student with a bachelor's degree, who is enrolled in graduate or first-professional courses.

POSTBACCALAUREATE STUDENTS NOT IN GRADUATE PROGRAMS. A student who has earned a baccalaureate degree and is enrolled in a graduate course at an institution, but who has not been granted graduate student status.

RACE/ETHNICITY. Categories used to describe groups to which individuals belong, identify with, or belong in the eyes of the community. The categories do not denote scientific definitions of anthropological origins. A person may be counted in only one group. The groups used to categorize U.S. citizens and resident aliens (holders of Form I-551/155) are:

Black, Non-Hispanic
American Indian or Alaskan Native
Asian or Pacific Islander
Hispanic
White, Non-Hispanic

REMEDIAL INSTRUCTIONAL PROGRAM/COURSES. Instructional activities designed for students deficient in the general competencies necessary for a regular postsecondary curriculum and educational setting.

SECOND-YEAR STUDENT. A student who has completed the equivalent of one year of full-time undergraduate work, that is, at least 30 semester hours, but less than 60 semester hours in a 120 hour program.

THIRD-YEAR STUDENT. A student who has completed the equivalent of two years of full-time undergraduate work, that is, at least 60 semester hours, but less than 90 semester hours in a 120 hour program.

UNCLASSIFIED STUDENT. A student taking courses creditable toward a degree or other formal award who cannot be classified by academic level. For example, this could include a transfer student whose earned credits have not been determined at the time of the fall report.

UNDERGRADUATE. A student enrolled in a four or five year bachelor's degree program, in an associate's degree program, or in a vocational or technical program below the baccalaureate.

WHITE, NON-HISPANIC. A person having origins in any of the original peoples of Europe, North Africa, or the Middle East.
