Ratio of Income to Poverty Level for Children under 18 Years as a Percentage of the Population for Whom Poverty Is Determined for Nebraska Legislative Districts from the 2007-2011 American Community Survey

The following tables and graphs look at the number and percentage of children by comparing their families' incomes to the poverty level. The data are from a U.S. Census Bureau program called the American Community Survey (ACS). The ACS is an ongoing, nation-wide survey conducted every month. Each year approximately 1 in 40 persons are sampled. During the past 5 years in Nebraska, there has been an average of about 40,000 persons interviewed per year.

While this annual number of interviews is adequate for state-level summaries, for smaller levels of geography like counties and legislative districts, only 5-year data are available for analysis. The estimates contained in this report are based on the both the single-year 2011 ACS and the 5-year 2007-2011 ACS. The 5-year estimates are period estimates. They represent the characteristics of the population over the specific data collection period.

The tables in this report are based on the District Boundaries for the 102nd Legislature and do not reflect the boundary changes following the 2010 Census. The new Legislative District boundaries will be used when the 2008-2012 ACS data are released in December 2013.

Below are definitions of some of the terms used in this report.

Individuals for Whom Poverty Status is Determined – Poverty status was determined for all people except institutionalized people, people in military group quarters, people in college dormitories, and unrelated individuals under 15 years old. These groups were excluded from the numerator and denominator when calculating poverty rates. Thus, the total population in poverty tables--the poverty universe--is slightly smaller than the overall population.

Specified Poverty Levels – To determine a person's poverty status, one compares the person's total family income in the last 12 months with the poverty threshold appropriate for that person's family size and composition (see example below). If the total income of that person's family is less than the threshold appropriate for that family, then the person is considered "below the poverty level," together with every member of his or her family. If a person is not living with anyone related by birth, marriage, or adoption, then the person's own income is compared with his or her poverty threshold. The total number of people below the poverty level is the sum of people in families and the number of unrelated individuals with incomes in the last 12 months below the poverty threshold.

Ratio of Income to Poverty – People and families are classified as being in poverty if their income is less than their poverty threshold. If their income is less than half their poverty threshold, they are below 50% of poverty; less than the threshold itself, they are in poverty (below 100% of poverty); less than 1.25 times the threshold, below 125% of poverty, and so on. As the ratio of income to poverty becomes greater, there will be more people who fall under the category, because higher ratios include more people with higher incomes.

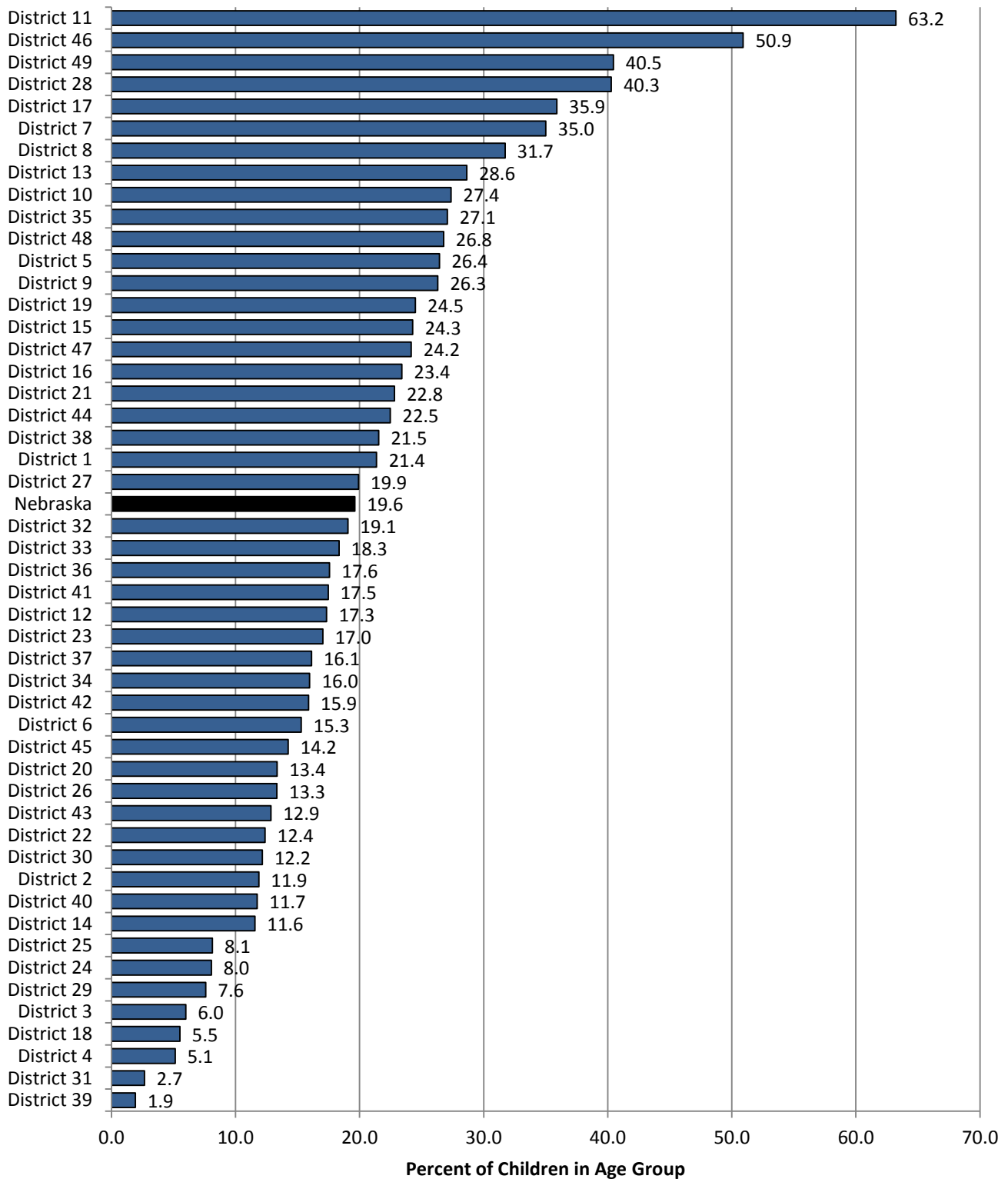

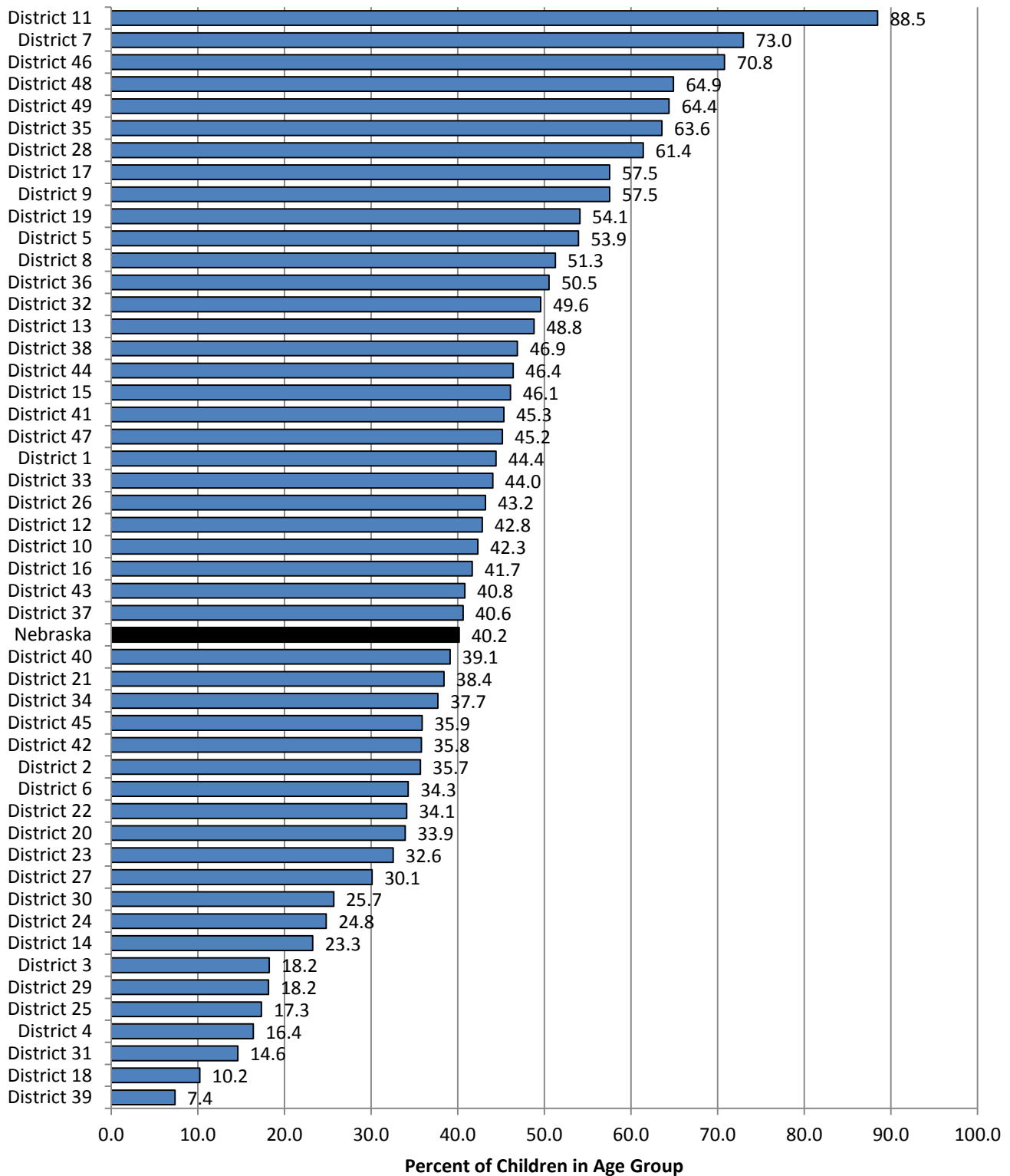
Figure 1. Children under 6 Years below 100% of Poverty as a Percentage of the Population for Whom Poverty is Determined for Nebraska Legislative Districts: 2007-2011

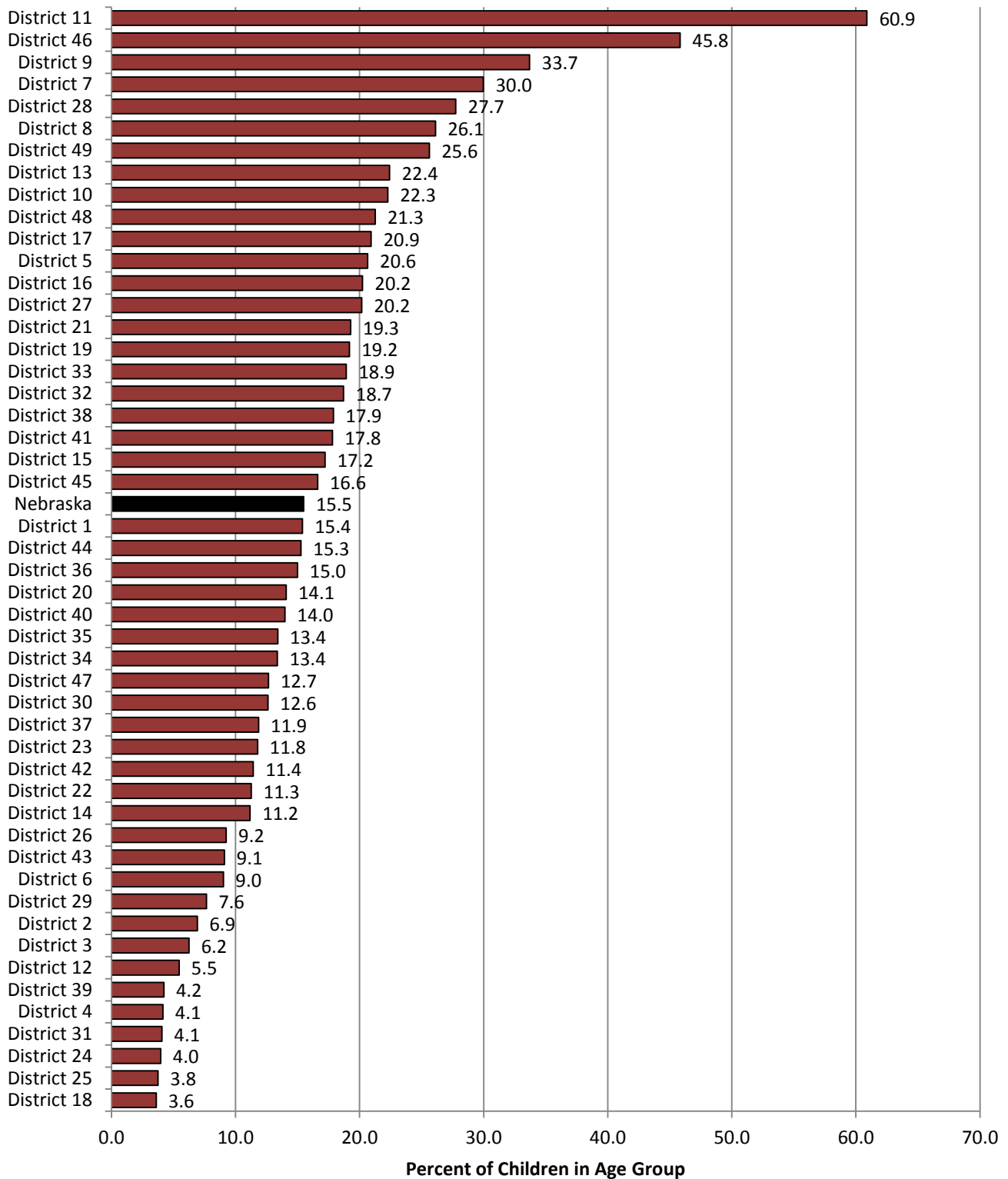
Figure 2. Children under 6 Years below 185% of Poverty as a Percentage of the Population for Whom Poverty is Determined for Nebraska Legislative Districts: 2007-2011

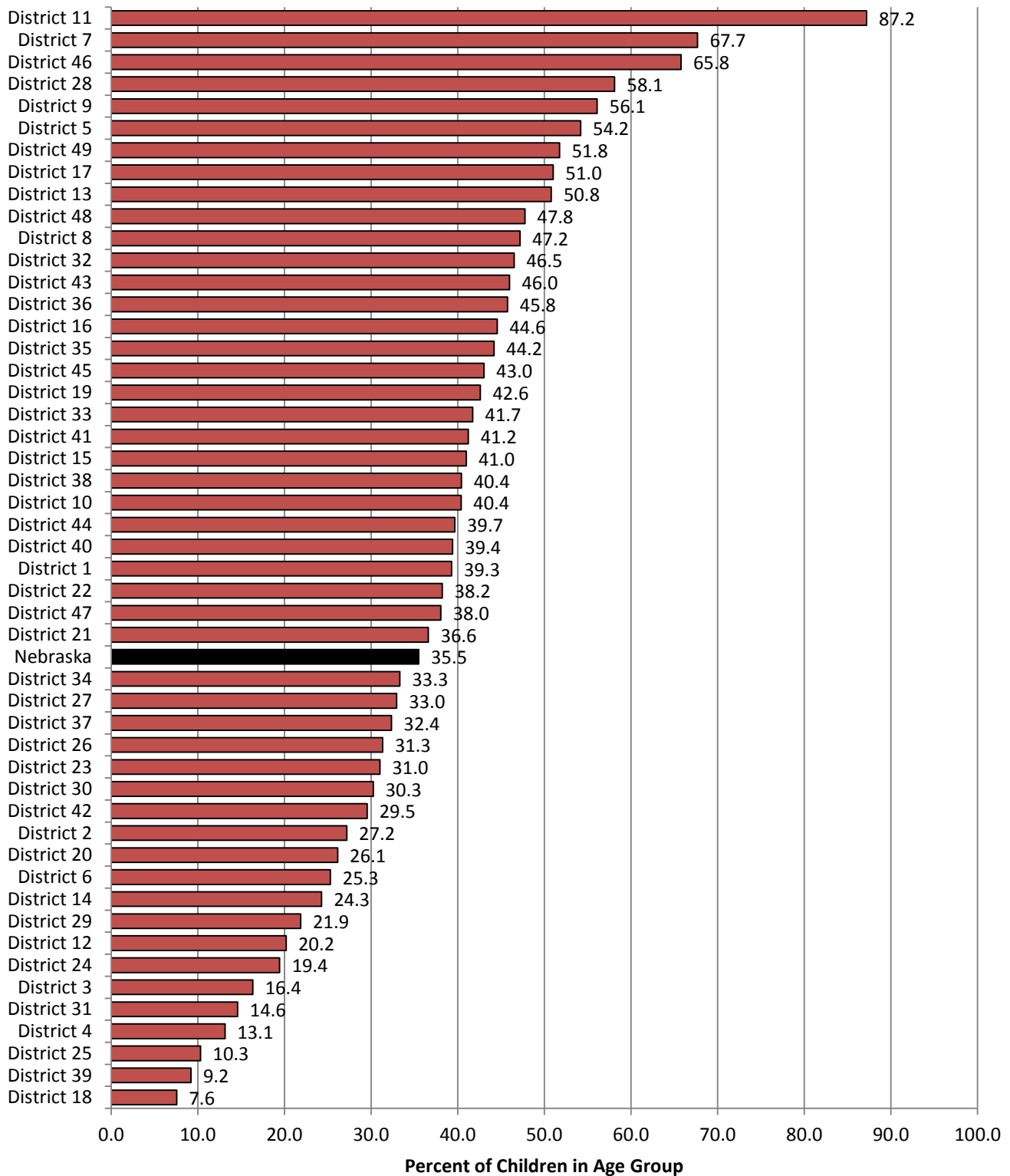
Figure 3. Children 6 to 11 Years below 100% of Poverty as a Percentage of the Population for Whom Poverty is Determined for Nebraska Legislative Districts: 2007-2011

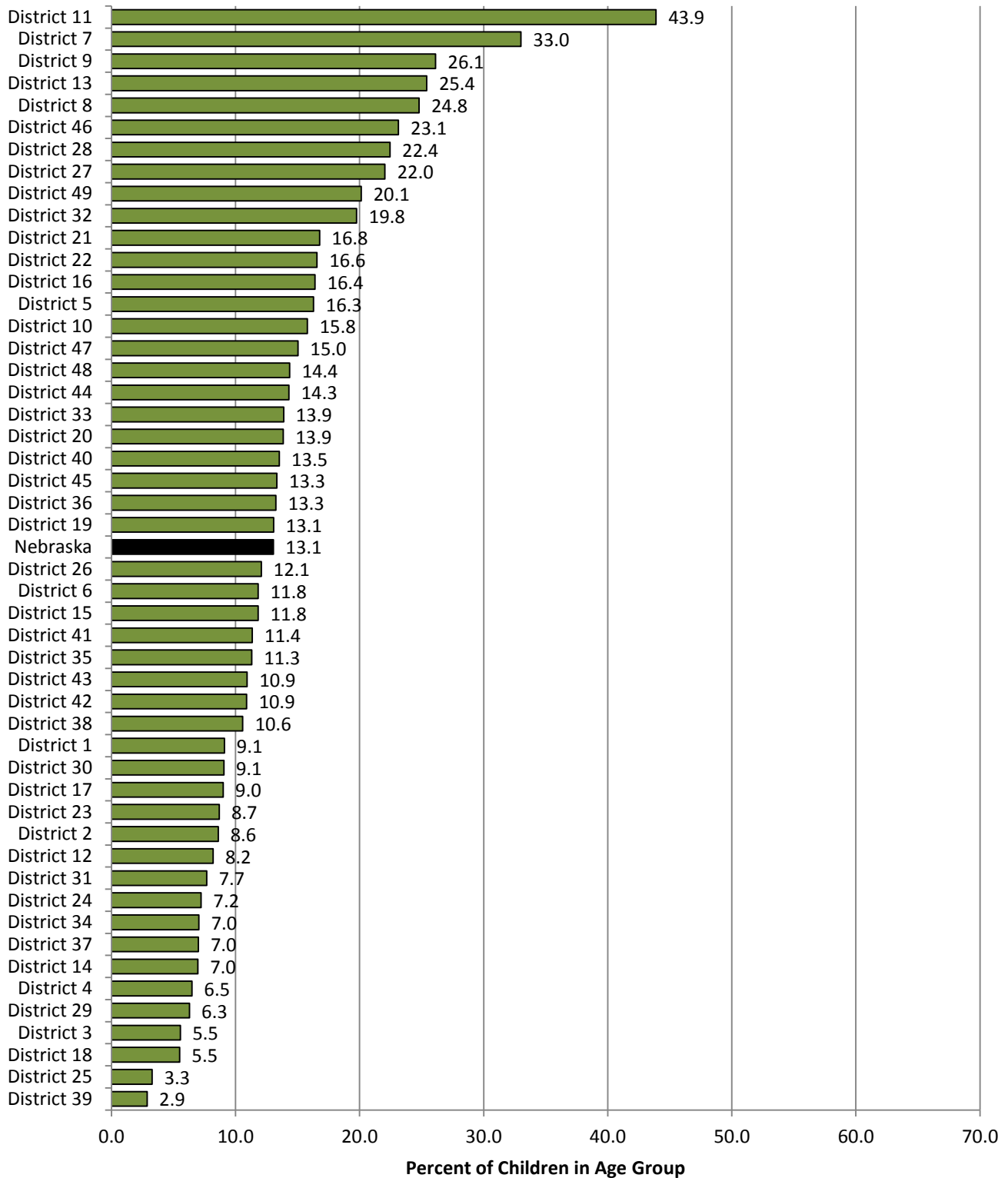
Figure 4. Children 6 to 11 Years below 185% of Poverty as a Percentage of the Population for Whom Poverty is Determined for Nebraska Legislative Districts: 2007-2011

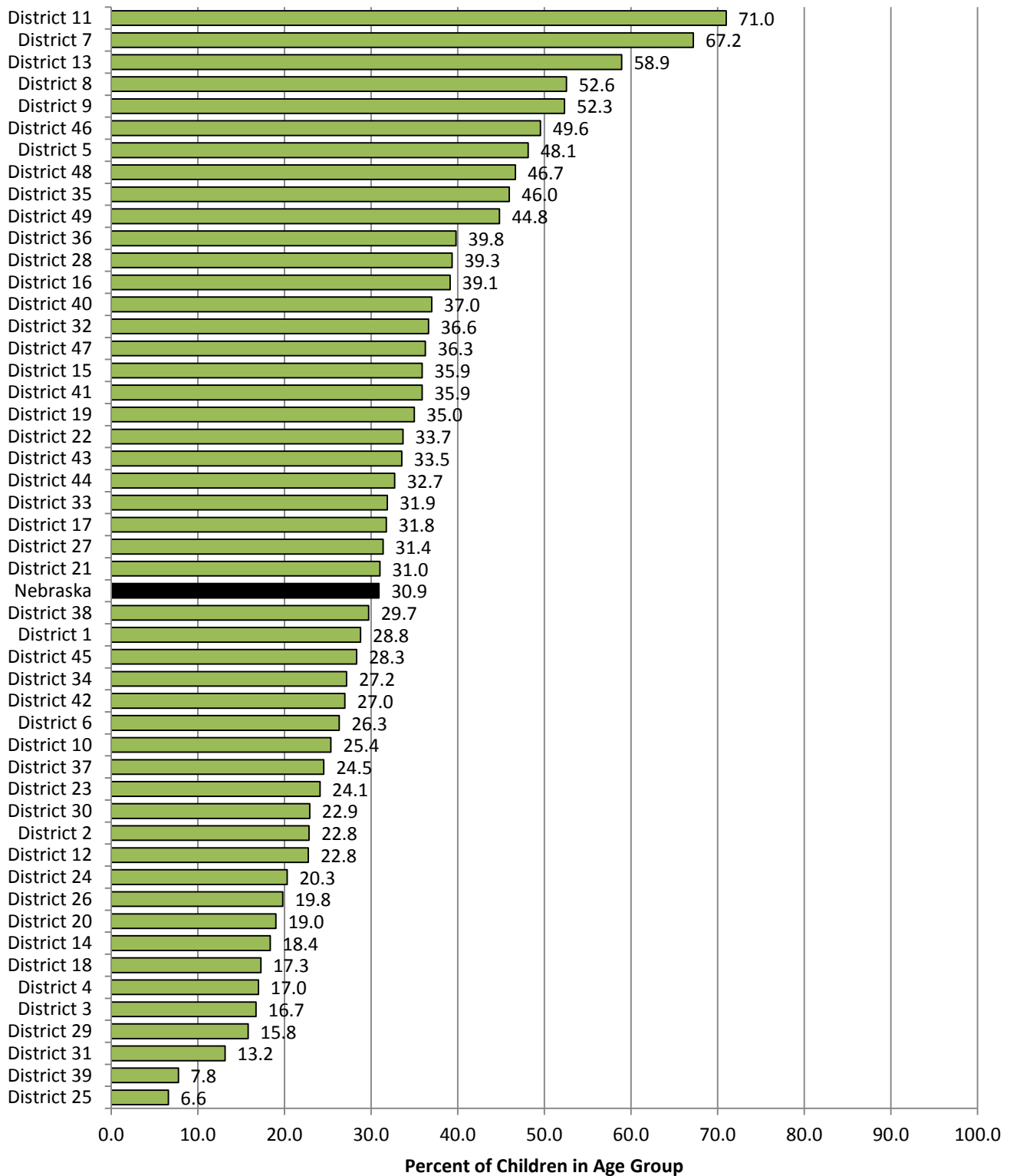
Figure 5. Children 12 to 17 Years below 100% of Poverty as a Percentage of the Population for Whom Poverty is Determined for Nebraska Legislative Districts: 2007-2011
