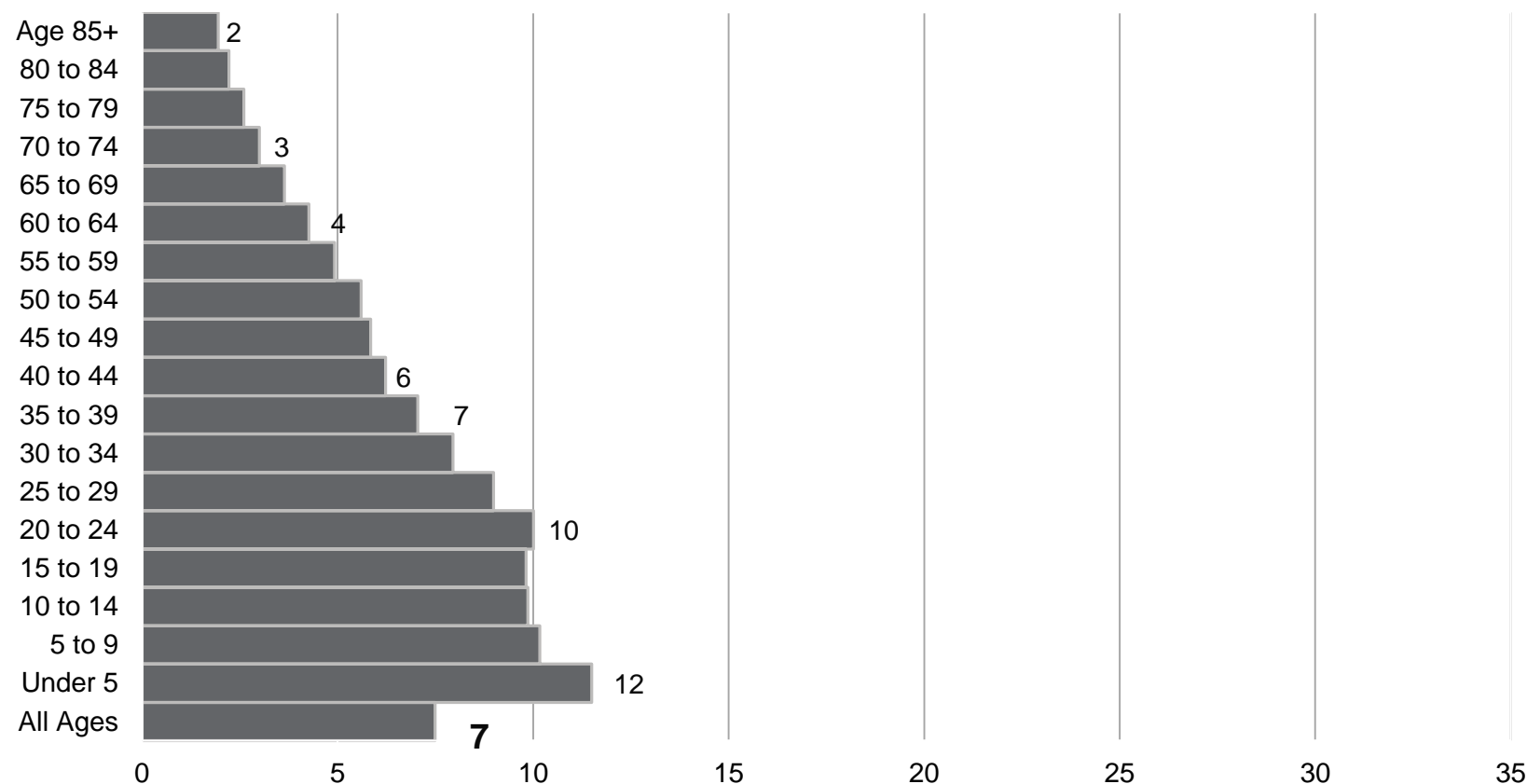

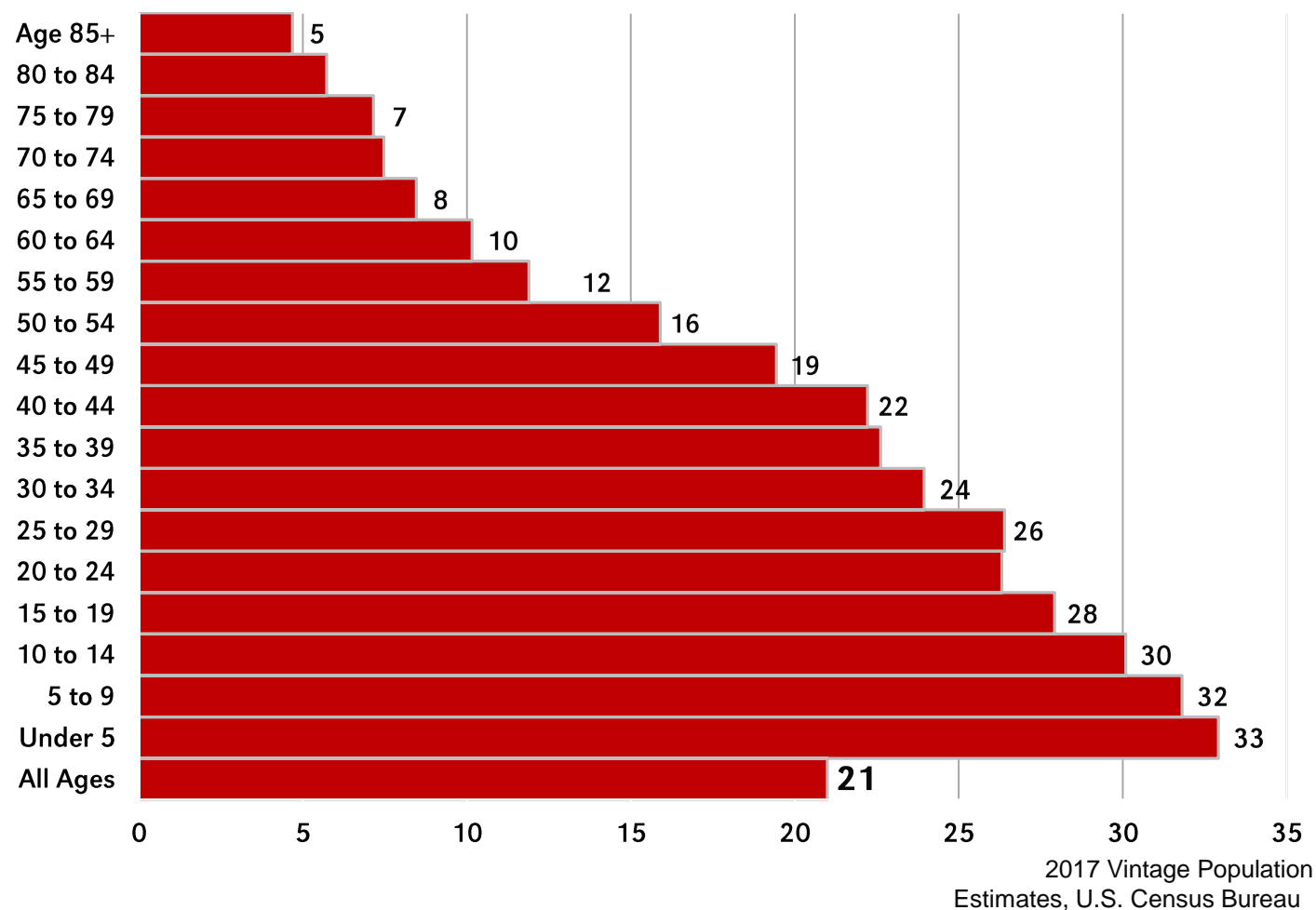
1990 Minority Population

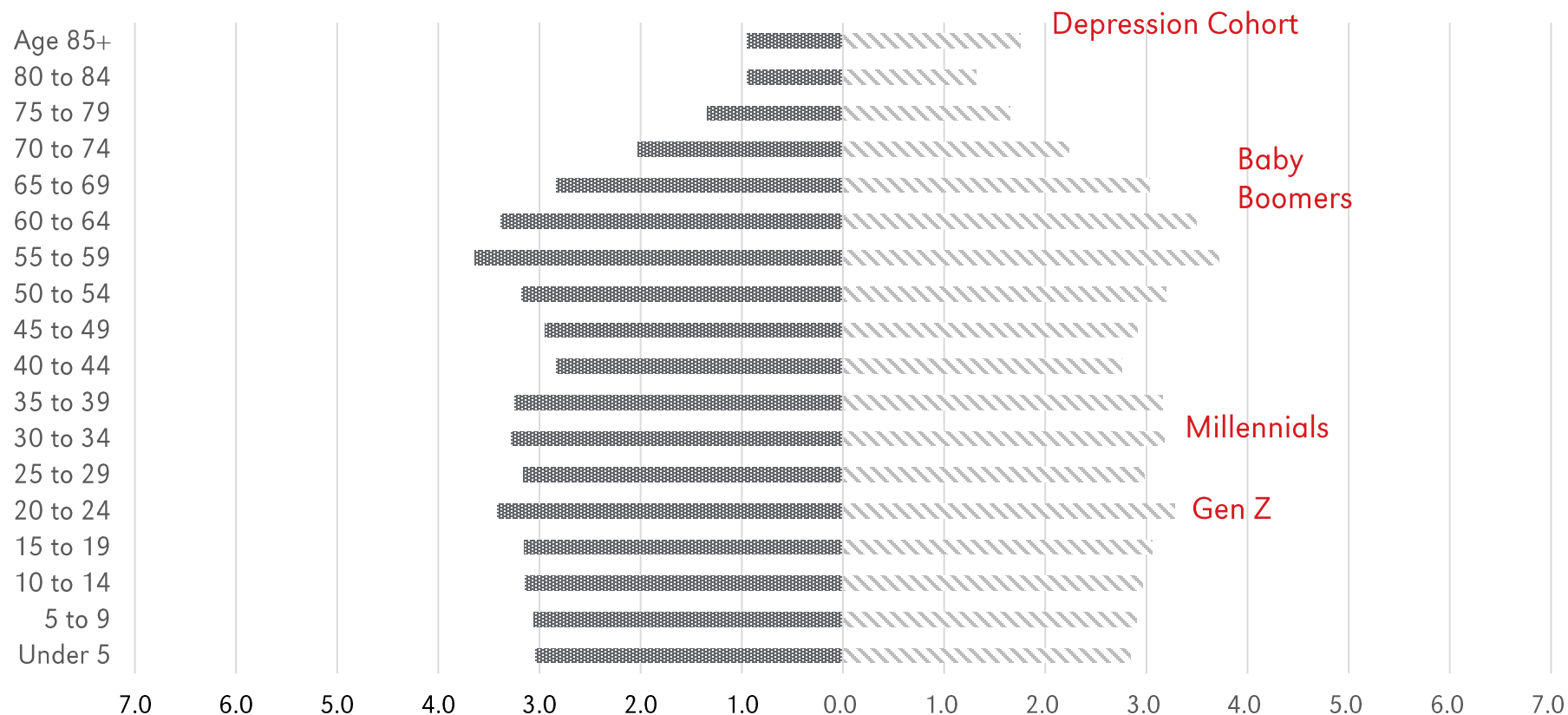

% of total population by age and gender

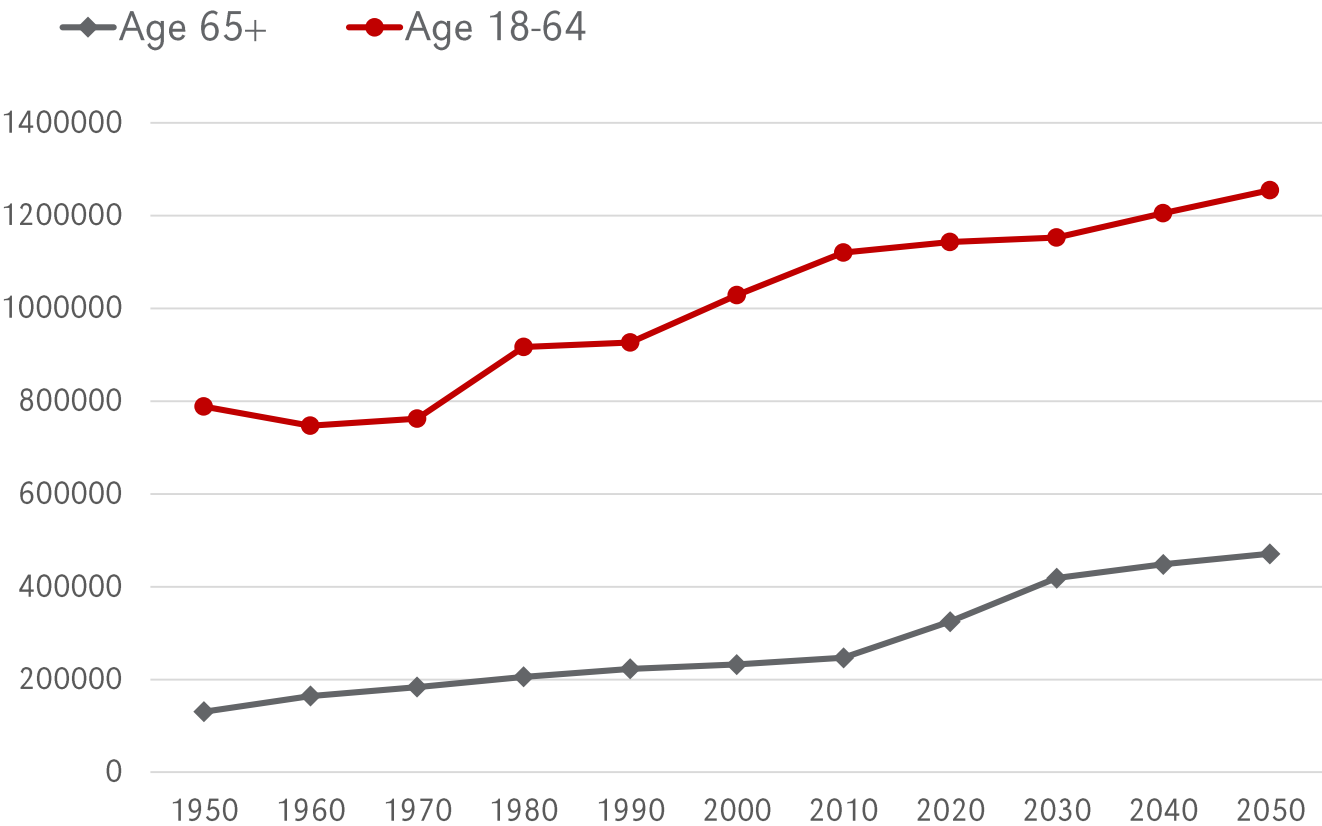

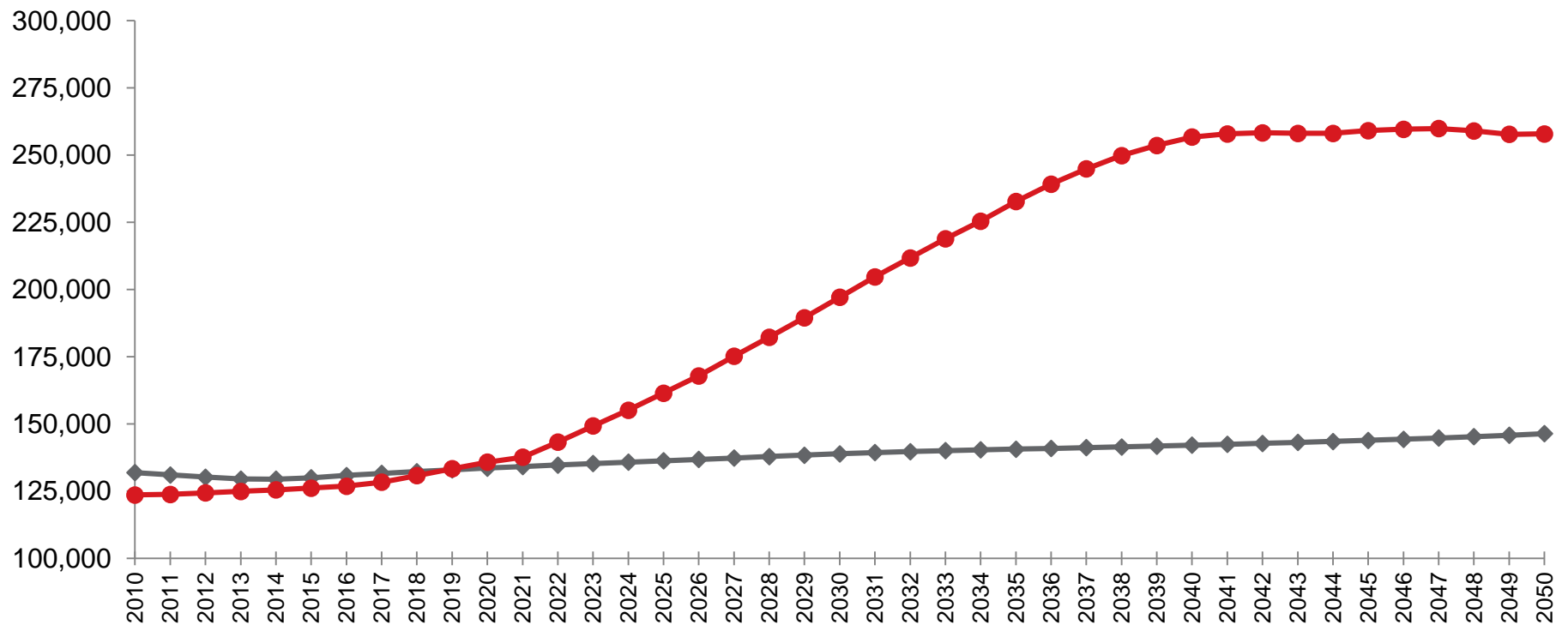

Nebraska population age 75 and over surpassed the population of under age 5 in 2018 and is expected to continue to increase

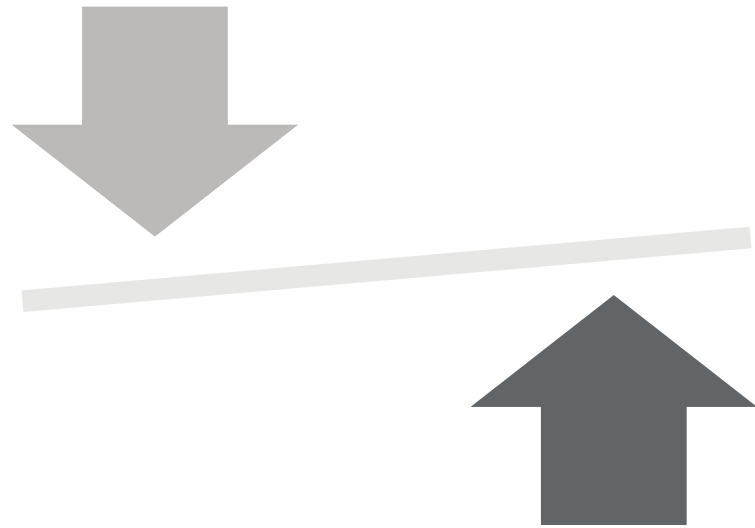
Real and projected populations

—♦— Population under age 5 —●— Population age 75+

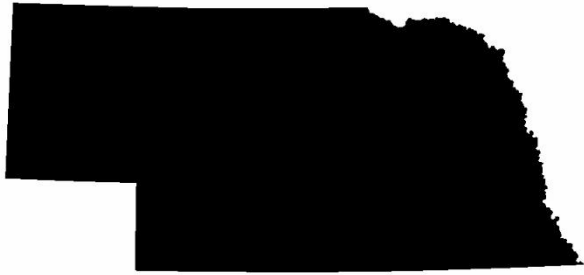

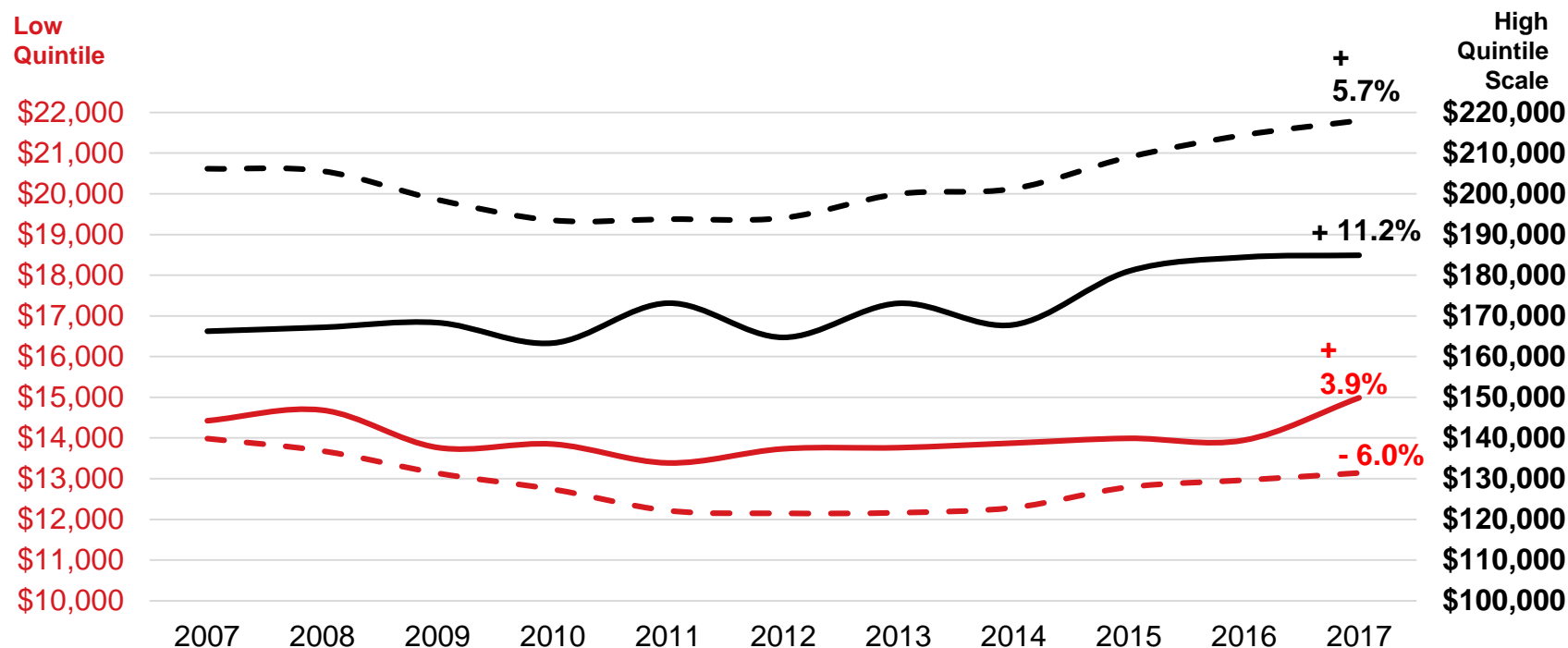

Nebraska growth in mean household income is flat but outpaces U.S.

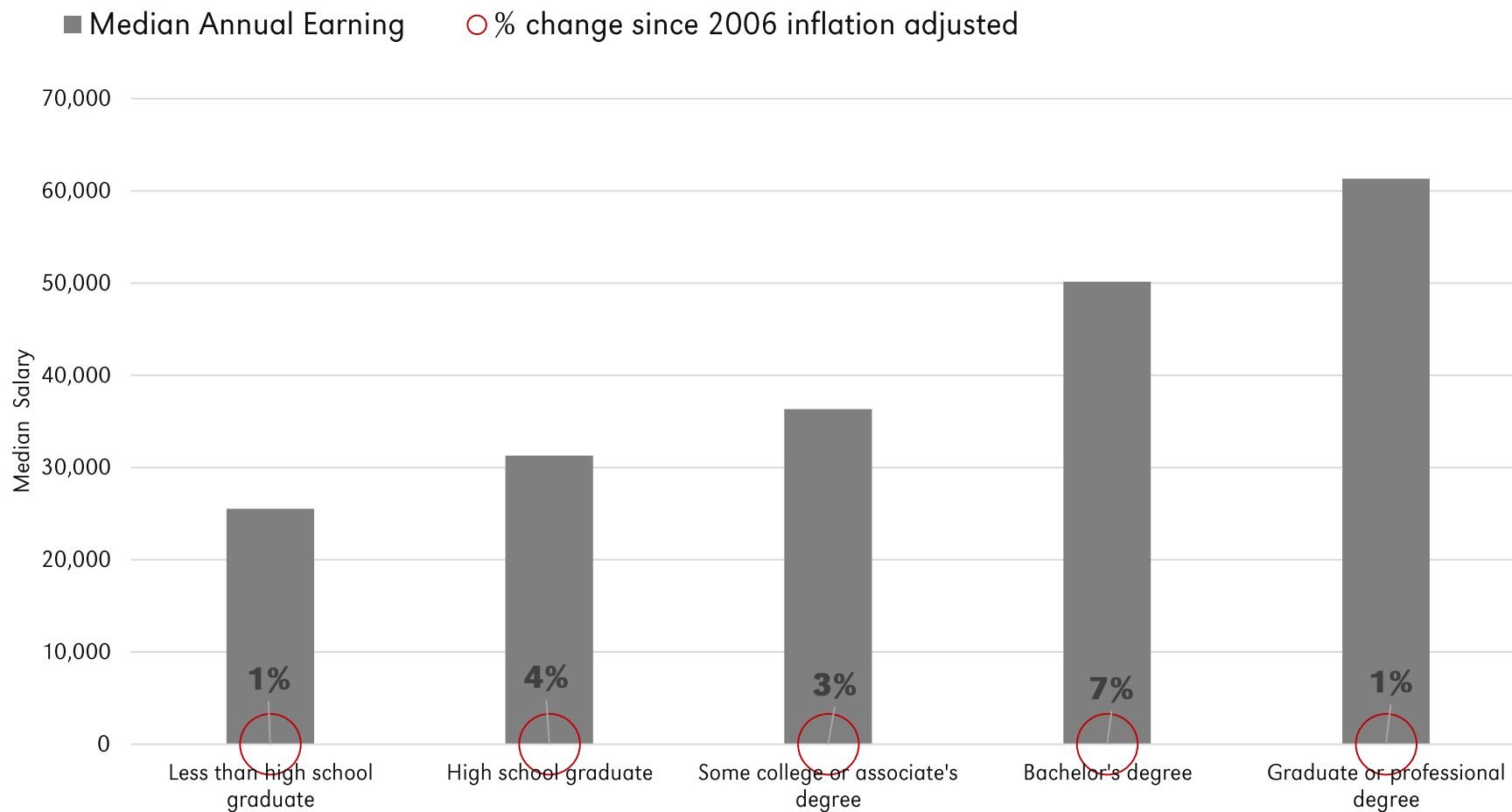
Inflation adjusted mean household income, 2007 to 2017 with % change

— Nebraska Lowest Quintile - - U.S. Lowest Quintile — Nebraska Highest Quintile - - U.S. Highest Quintile



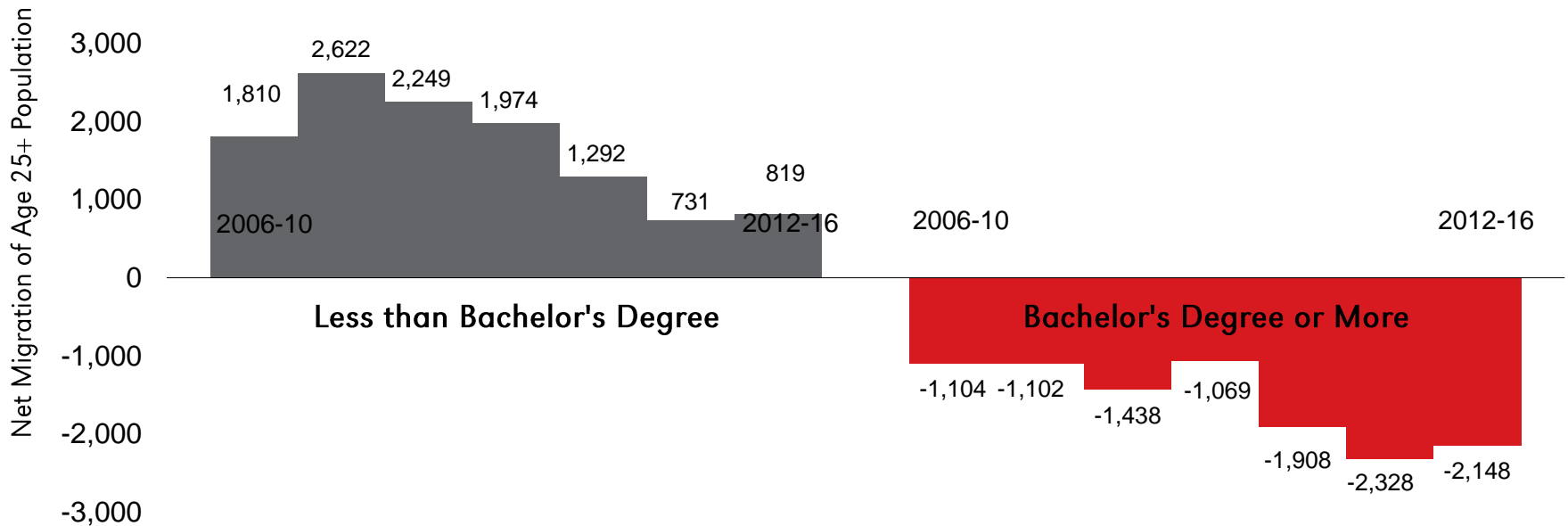

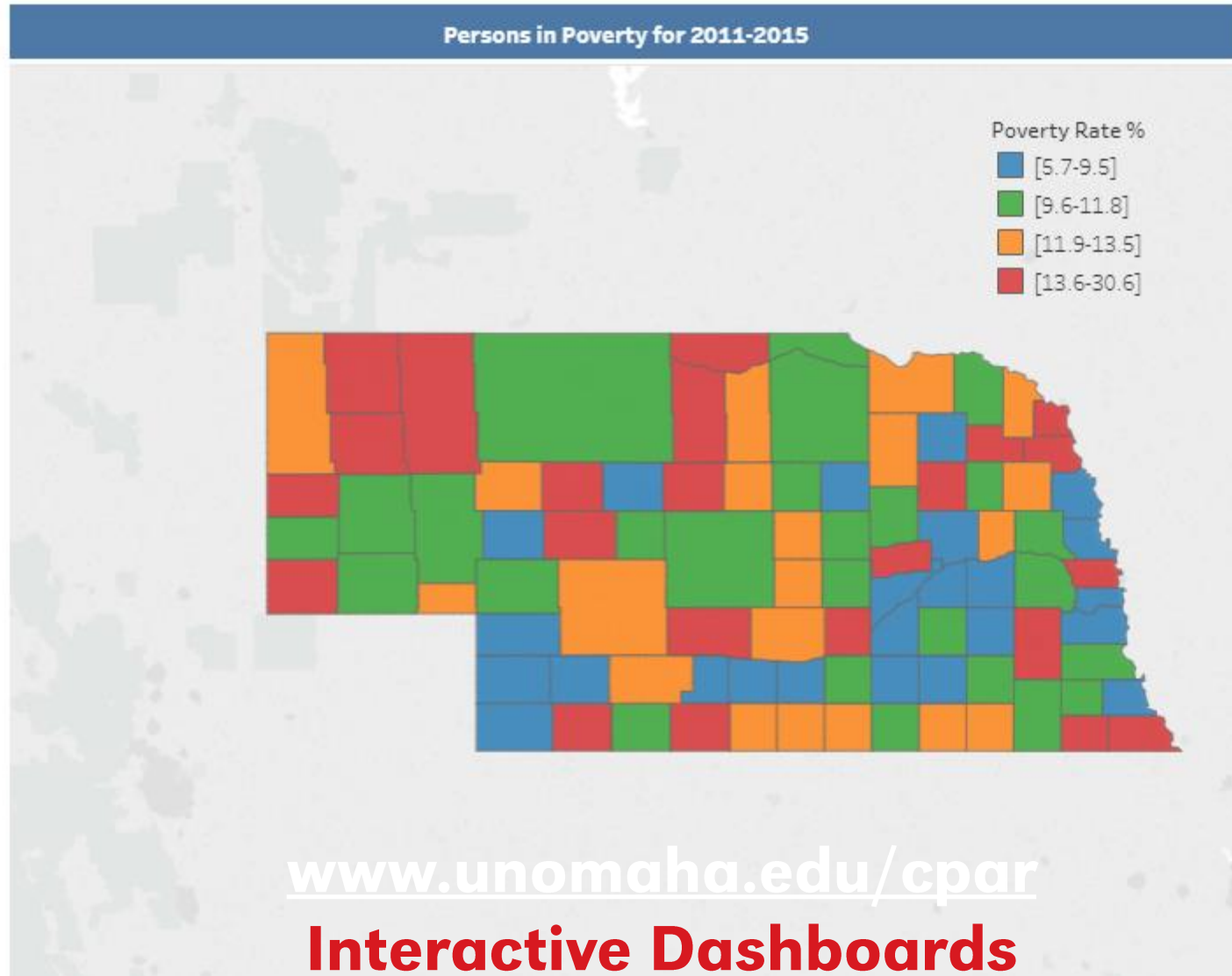

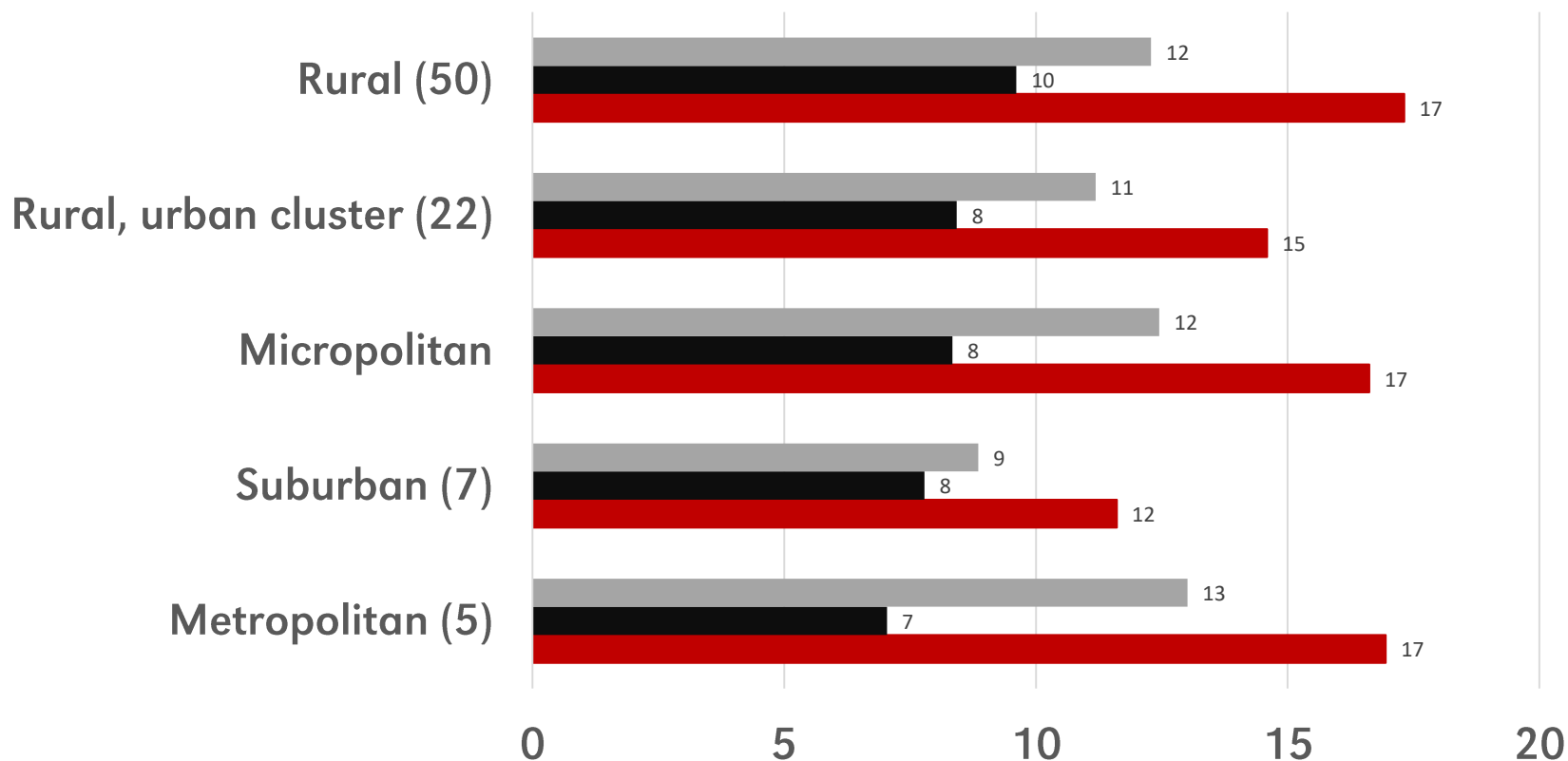


Poverty



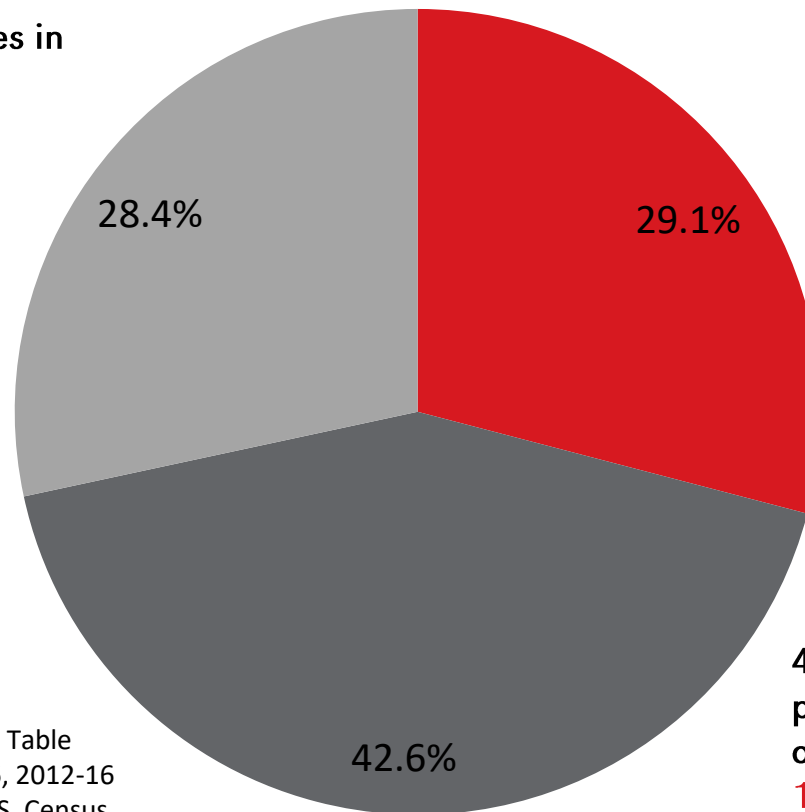
Poverty is highest, for all groups and overall, in rural counties

2nd lowest among all states.

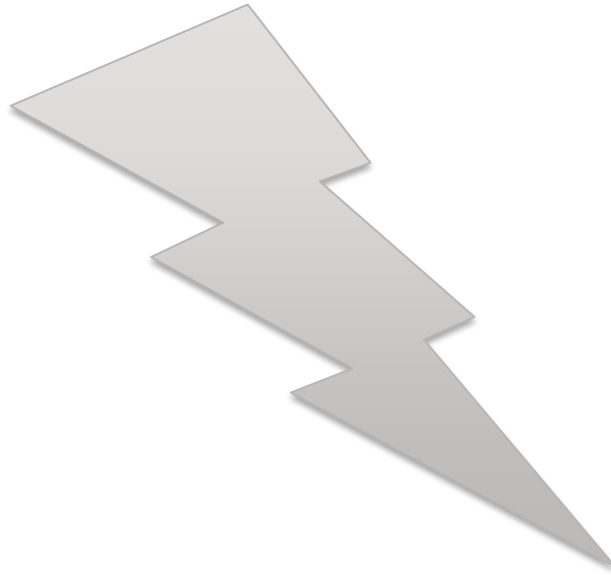


29% of Nebraska families in poverty – head of household or spouse works full time **2nd highest among all states.**
