Legislature's Planning Committee: 2014 Associated Reports

The Nebraska Legislature's Planning Committee was created in 2009 with the passage of LB 653 in order to help establish a process of long-term state planning with the Nebraska Legislature. The committee was created to assist state government in identifying emerging trends, assets and challenges of the state and the long-term implications of the decisions made by the Nebraska Legislature.

Efforts during the first two years of the committee focused on the development of a database. The goals and benchmarks included in the database were developed and approved by the Legislature's Planning Committee to present a common-sense and data-driven assessment of key areas important to Nebraskans' quality of life. This database was a joint initiative with the Nebraska Legislature's Planning Committee and the University of Nebraska at Omaha's College of Public Affairs and Community Service (CPACS). The database was presented in a report that consisted of the data and summaries of the data for each of the nine categories of benchmarks established by the Planning Committee. Each year, the Planning Committee is in charge of updating the data for all benchmarks in each category. It is hoped that this will be of instrumental assistance to Legislators and staff as they craft and debate legislation each Session.

In addition to the statewide database, CPACS has prepared a series of Associated Reports for the Planning Committee that provides data for Legislative Districts, counties, and census tracts. These reports address the benchmarks established by the Planning Committee. These reports include:

Introduction

These Legislative District Quick Facts tables are summary profiles showing frequently requested data items from the Census Bureau's American Community Survey. The data in these tables are for the two five-year periods for which data are available since the Legislature was redistricted in 2011. These items also demonstrate the wide variety of data available for Nebraska's Legislative Districts. These same data also are available for all of Nebraska's counties and communities.

The tables in this report are based on the District Boundaries for the 103rd Legislature that were approved by the Legislature in 2011 and were based on the data from the 2010 Census. Because of changes in Legislative District boundaries, the tables in this report are not directly comparable to prior reports using the previous boundaries.


On December 4, 2014, the U.S. Census Bureau released five-year American Community Survey (ACS) estimates for the combined years of 2009 through 2013, making available social, economic, housing and demographic statistics for every county and community in Nebraska and the nation. Also available are estimates for Nebraska's Legislative Districts.


The data are based on a rolling national sample survey mailed each year from 2009 through 2013. By pooling several years of survey responses, the ACS can generate detailed statistical portraits of smaller geographies such as legislative districts. The Census Bureau issues new sets of these five-year estimates every year, permitting users to track trends in even the smallest of areas over time. This is the second set of five-year estimates available using the 2011 boundaries. For comparison purposes, both sets of estimates are presented in this report.

The new 2009-2013 ACS estimates are not related to the 2010 Census population counts that have been released. The ACS complements the decennial count and provides estimates of population characteristics that are far more detailed than the basic demographic information that has been released from the 2010 Census.

Because it is a survey based on a sample of the population rather than the entire population, the ACS produces estimates, not actual counts. Since it is based on a sample, the ACS also is subject to sampling error. To aid data users, the Census Bureau calculates and publishes a margin of error for every ACS estimate it produces.

Changes in Selected Indicators between the 2008-2012 and 2009-2013 Periods

Figures 1 through 5 on the following pages highlight some of the data from the tables in this report and point out changes that occurred in legislative districts between the periods 2008-2012 and 2009-2013. When comparing estimates from two multiyear periods, ideally comparisons should be based on non-overlapping periods (e.g., comparing estimates from 2008–2012 with estimates from 2013–2017). The comparison of two estimates for different, but overlapping periods is challenging since the difference is driven by the non-overlapping years. For example, when comparing the 2008–2012 period with estimates from the 2009–2013 period, data for 2009, 2010, 2011, and 2012 are included in both estimates. Their contribution is subtracted out when the estimate of differences is calculated. While the interpretation of this difference is difficult, these comparisons can be made with caution. Although it is not possible to isolate those differences using these two successive 5-year estimates, the estimate of the difference can be interpreted as a reflection of the "average annual change" between 2008 and 2013.

Population

Looking at Figure 1, then, it appears that the majority of Nebraska's legislative districts were increasing in population with an average annual increase of 292 persons. Those districts which grow faster than the state average will likely decrease in geographic area during redistricting after the next census, while those growing slower or declining are likely to increase in geographic area. Overall, 13 districts lost population, and the remaining 36 added population. District 9 was the most rapidly growing district, while District 13 lost the most population. Of the 13 declining Legislative Districts, 1 was in Douglas County, 1 was in Lancaster County, and the remaining 11 were in Greater Nebraska (outside the Omaha and Lincoln areas).

Median Household Income

Figure 2 compares changes in median household incomes between the 2008-2012 and 2009-2013 periods. The state averaged a \$456 average annual decline in median household income (adjusted for inflation). Of the state's legislative districts, 19 recorded increasing incomes, while 30 recorded declining incomes. District 39 had the largest increase in median household income, and District 27 had largest decrease. Possibly reflecting improved farm income, 10 of the districts with increased incomes were located in Greater Nebraska, 3 were in Lancaster County, 2 were in Sarpy County, and 4 were in Douglas County.

Poverty

Figure 3 looks at changes in the poverty rates for legislative districts. The values in this figure represent the differences in the poverty rates between the 2008-2012 and 2009-2013 periods. As such, they are not a percentage change in the number of people below poverty rather simply the poverty rates from the earlier period subtracted from the poverty rates of the later period. Examining Figure 3 shows that Nebraska averaged a 0.4 percentage point increase in the average poverty rate between the 2 periods. In 18 legislative districts poverty rates were the

same or lower, and in 31 districts poverty rates were higher. District 5 registered the biggest increase in its poverty rate, and District 48 had the largest decline. A sizeable number (7) of the legislative districts without increases in their poverty rates were in Douglas County. Additionally, 2 were in Sarpy County, and 2 were in Lancaster County. The remaining 7 districts without increases in poverty rates were in Greater Nebraska.

Unemployment

Another indicator of the economic well-being of an area is its unemployment rate. Figure 4 reviews unemployment rate changes between the 2008-2012 and 2009-2013 periods. Values in this figure are measured the same as those in the preceding figure. Reflecting the national recession during the first years in the period, Figure 4 shows that Nebraska's unemployment rate increased an average of 0.1 percentage points between the periods. Overall, 21 districts recorded the same or improved unemployment rates, while 38 districts reported worsening unemployment. By area of the state, Greater Nebraska had 10 legislative districts with steady or improved unemployment rates. There also were 7 districts in Douglas County, 1 in Sarpy County, and 3 in Lancaster County.

Housing Value

The final indicator in this section is the median value of owner-occupied housing units. This information is presented in Figure 5 and indicates that the median owner-occupied housing value fell an average of \$500 annually when comparing the two periods. Nineteen legislative districts experienced either no change or an increase in median housing values, and 30 districts lost value. The strength in Nebraska's housing was in Greater Nebraska, as 15 districts recorded increases in median value. Of the 4 remaining districts, 3 were in Douglas County and 1 was in Sarpy County.





Figure 2. Change in the Median Household Income for Nebraska Legislative Districts: 2008-2012 to 2009-2013 (2013 dollars) District 39 \$1,668 District 30 \$1,496 District 9 \$1,495 District 15 \$1,476 District 38 \$1,355 District 17 \$1,303 District 24 \$1,103 District 35 \$936 District 49 \$837 District 46 \$591 District 40 \$488 District 36 \$431 District 8 \$348 District 45 \$325 District 21 \$215 District 43 \$208 District 6 \$141 District 23 \$137 District 47 \$41 District 34 -\$25 District 31 -\$57 District 19 -\$109 **[** District 5 -\$191 District 41 -\$195 District 13 -\$249 District 48 -\$295 **[** District 11 -\$339 -\$360 District 7 District 33 -\$376 -\$456 **I** Nebraska District 25 -\$505 District 26 -\$584 District 22 -\$606 District 32 -\$645 District 37 -\$658 District 44 -\$830 **I** -\$877 District 1 District 4 -\$1,013 District 2 -\$1,029 District 29 -\$1,269 District 3 -\$1,285 -\$1,588 District 10 District 18 -\$1,684 District 20 -\$1,700 District 42 ·\$1,942 [District 16 -\$2,043 District 28 -\$2,139 **[** District 12 -\$2,473 District 14 -\$2,493 District 27 -\$3,659 -\$3,500 -\$1,500 -\$500 \$500 \$2,500 -\$4,500 -\$2,500 \$1,500 Change in Income Source: U.S. Census Bureau, 2009-2013 and 2008-2012 American Community Survey Prepared by: Center for Public Affairs Research, University of Nebraska at Omaha, January 2015






Figure 5. Change in the Median Value of Owner-Occupied Housing Units for Nebraska Legislative Districts: 2008-2012 to 2009-2013 (2013 dollars) District 49 \$4.000 District 24 \$3,600 District 41 \$3,000 District 17 \$2,600 District 36 \$2,400 District 44 \$2,000 District 22 \$1,900 District 11 \$1,800 District 48 \$1,700 District 9 \$1,600 District 23 \$1,400 District 40 \$1,300 District 37 \$1,100 District 19 \$1,000 District 42 \$900 District 33 \$800 \$300 District 34 District 47 \$100 District 8 \$0 District 29 -\$100 District 43 -\$200 🗖 District 38 -\$300 🗀 -\$300 🗀 District 27 District 21 -\$300 District 45 -\$400 E Nebraska -\$500 **I** -\$700 District 13 -\$1,000 District 25 District 7 -\$1,000 District 6 -\$1,000 District 1 -\$1,000 District 46 -\$1,200 District 30 -\$1,400 District 28 -\$1,600 District 5 -\$1,700 District 16 -\$1,800 District 20 -\$2,300 District 15 -\$2,300 District 10 -\$2,400 District 4 -\$2,400 District 26 -\$2,600 District 18 -\$2,800 **[** District 12 -\$3,200 **E** -\$3,600 **E** District 14 District 2 -\$3,600 **E** District 32 -\$4,200 District 35 -\$4,300 **E** District 31 -\$4,300 -\$4,600 District 39 District 3 -\$6,200 -\$6,000 -\$4,000 -\$2,000 \$2,000 \$6,000 -\$8,000 \$0 \$4,000 **Change in Value** Source: U.S. Census Bureau, 2009-2013 and 2008-2012 American Community Survey Prepared by: Center for Public Affairs Research, University of Nebraska at Omaha, January 2015

Definitions

Age – The age classification is based on the age of the person in complete years at the time of interview. Both age and date of birth are used in combination to calculate the most accurate age at the time of the interview. Respondents are asked to give an age in whole, completed years as of interview date as well as the month, day and year of birth. People are not to round an age up if the person is close to having a birthday and to estimate an age if the exact age is not known. An additional instruction on babies also asks respondents to print "0" for babies less than one year old.

Race – There are several concepts used to display and tabulate race information for the six major race categories (White; Black or African American; American Indian or Alaska Native; Asian; Native Hawaiian or Other Pacific Islander; and Some Other Race).

Race is a self-identification data item in which respondents choose the race or races with which they most closely identify. People may choose to report <u>more than one race</u> to indicate their racial mixture, such as "American Indian" and "White."

The concept "race alone" includes people who reported a single entry (i.e., Korean) and no other race, as well as people who reported two or more entries within the same major race group (i.e., Asian). The race alone categories includes the minimum 5 race categories required by OMB, plus the 'some other race alone' included by the Census Bureau with the approval of OMB. The race alone categories in tables 2 and 3 are:

White alone
Black or African-American alone
American Indian or Alaska Native alone
Asian alone
Native Hawaiian or other Pacific Islander alone
Some other race alone

Hispanic Origin – Origin can be viewed as the heritage, nationality group, lineage, or country of birth of the person or the person's parents or ancestors before their arrival in the United States. People who identify their origin as Spanish, Hispanic, or Latino <u>may be of any race</u>.

Foreign Born – The foreign-born population includes anyone who was not a U.S. citizen or a U.S. national at birth. This includes respondents who indicated they were a U.S. citizen by naturalization or not a U.S. citizen.

Educational Attainment – Educational attainment data are tabulated for people 25 years old and over. Respondents are classified according to the highest degree or the highest level of school completed. The question included instructions for persons currently enrolled in school to report the level of the previous grade attended or the highest degree received.

The educational attainment question included a response category that allowed people to report completing the 12th grade without receiving a high school diploma. Respondents who received a regular high school diploma and did not attend college

were instructed to report "Regular high school diploma." Respondents who received the equivalent of a high school diploma (for example, passed the test of General Educational Development (G.E.D.)), and did not attend college, were instructed to report "GED or alternative credential." "Some college" is in two categories: "Some college credit, but less than 1 year of college credit" and "1 or more years of college credit, no degree." The category "Associate's degree" included people whose highest degree is an associate's degree, which generally requires 2 years of college level work and is either in an occupational program that prepares them for a specific occupation, or an academic program primarily in the arts and sciences. The course work may or may not be transferable to a bachelor's degree.

High School Graduate or Higher – This category includes people whose highest degree was a high school diploma or its equivalent, people who attended college but did not receive a degree, and people who received an associate's, bachelor's, master's, or professional or doctorate degree. People who reported completing the 12th grade but not receiving a diploma are not included.

Bachelor's Degree of Higher – This category includes people whose highest degree was a bachelor's, master's, or professional or doctorate degree.

Individuals for Whom Poverty Status is Determined – Poverty status was determined for all people except institutionalized people, people in military group quarters, people in college dormitories, and unrelated individuals under 15 years old. These groups were excluded from the numerator and denominator when calculating poverty rates. Thus, the total population in poverty tables--the poverty universe--is slightly smaller than the overall population.

Specified Poverty Levels – To determine a person's poverty status, one compares the person's total family income in the last 12 months with the poverty threshold appropriate for that person's family size and composition (see example below). If the total income of that person's family is less than the threshold appropriate for that family, then the person is considered "below the poverty level," together with every member of his or her family. If a person is not living with anyone related by birth, marriage, or adoption, then the person's own income is compared with his or her poverty threshold. The total number of people below the poverty level is the sum of people in families and the number of unrelated individuals with incomes in the last 12 months below the poverty threshold.

Household – A household includes all the people who occupy a housing unit as their usual place of residence. Income

Total Income – Total income is the sum of the amounts reported separately for wages, salary, commissions, bonuses, or tips; self-employment income from own nonfarm or farm businesses, including proprietorships and partnerships; interest, dividends, net rental income, royalty income, or income from estates and trusts; Social Security or Railroad Retirement income; Supplemental Security Income (SSI); any public assistance or welfare payments from the state or local welfare office; retirement, survivor, or disability pensions; and any other sources of income received regularly such as Veterans' (VA) payments, unemployment compensation, child support, or alimony.

Labor Force – The labor force includes all people classified in the civilian labor force, plus members of the U.S. Armed Forces (people on active duty with the United States Army, Air Force, Navy, Marine Corps, or Coast Guard). The Civilian Labor Force consists of people classified as employed or unemployed.

Labor Force Participation Rate – The labor force participation rate is the percent of the population aged 16 years and over that is in the labor force.

Employed – This measure includes all civilians 16 years old and over who were either (1) "at work" — those who did any work at all during the reference week as paid employees, worked in their own business or profession, worked on their own farm, or worked 15 hours or more as unpaid workers on a family farm or in a family business; or (2) were "with a job but not at work" — those who did not work during the reference week but had jobs or businesses from which they were temporarily absent due to illness, bad weather, industrial dispute, vacation, or other personal reasons. Excluded from the employed are people whose only activity consisted of work around the house or unpaid volunteer work for religious, charitable, and similar organizations; also excluded are people on active duty in the United States Armed Forces. The reference week is the calendar week preceding the date on which the respondents completed their questionnaires or were interviewed. This week may not be the same for all respondents.

Unemployed – All civilians 16 years old and over are classified as unemployed if they (1) were neither "at work" nor "with a job but not at work" during the reference week, and (2) were actively looking for work during the last 4 weeks, and (3) were available to accept a job. Also included as unemployed are civilians who did not work at all during the reference week, were waiting to be called back to a job from which they had been laid off, and were available for work except for temporary illness.

Unemployment Rate – The unemployment rate is the percentage of the civilian labor force that is unemployed.

Own Child – A never-married child under 18 years who is a son or daughter by birth, a stepchild, or an adopted child of the householder. In certain tabulations, own children are further classified as living with two parents or with one parent only. Own children of the householder living with two parents are by definition found only in married-couple families. (Note: When used in "EMPLOYMENT STATUS" tabulations, own child refers to a never married child under the age of 18 in a family or a subfamily who is a son or daughter, by birth, marriage, or adoption, of a member of the householder's family, but not necessarily of the householder.)

All Parents in Labor Force – If a child lives with two parents, then both parents are in the labor force. If a child lives with one parent only, then that parent is in the labor force.

School Enrollment – Children are classified as enrolled in school if they were attending a public or private school at any time during the 3 months prior to the time of interview. The question included instructions to "include only nursery or preschool, kindergarten, elementary school, home school, and schooling which leads to a high school diploma, or a college degree."

Enrolled in Public and Private School – This category classifies children who attended school in the reference period and indicated they were enrolled by marking one of the questionnaire categories for "public school, public college" or "private school, private college." The instruction guide defines a public school as "any school or college controlled and supported primarily by a local, county, state, or federal government." Private schools are defined as schools supported and controlled primarily by religious organizations or other private groups. Respondents who marked both the "public" and "private" boxes are edited to the first entry, "public."

Health Insurance Coverage – Health insurance coverage includes plans and programs that provide comprehensive health coverage. Plans that provide insurance for specific conditions or situations such as cancer and long-term care policies are not considered coverage. Likewise, other types of insurance like dental, vision, life, and disability insurance are not considered health insurance coverage.

People were considered insured if they reported at least one "yes" to any of the following categories.

- Insurance through a current or former employer or union (of this person or another family member)
- Insurance purchased directly from an insurance company (by this person or another family member)
- Medicare, for people 65 and older, or people with certain disabilities
- Medicaid, Medical Assistance, or any kind of government-assistance plan for those with low incomes or a disability
- TRICARE or other military health care
- VA (including those who have ever used or enrolled for VA health care)
